

## **END-USER LICENSE AGREEMENT FOR SharePoint PDF Service**

### **IMPORTANT: PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL:**

GETYOURNET IT SERVICES End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and GETYOURNET IT SERVICES. For the GETYOURNET IT SERVICES software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and GETYOURNET IT SERVICES, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

#### **1. GRANT OF LICENSE.**

The SOFTWARE PRODUCT is licensed as follows:

##### **(a) Installation and Use.**

GETYOURNET IT SERVICES grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed [e.g., Windows 95, Windows NT, Windows 98, Windows 2000, Windows Server 2003, Windows Server 2008/R2, Windows Server 2012/R2, Windows XP, Windows ME, Windows Vista, Windows 8, Windows 8.1, Windows 10].

##### **(b) Backup Copies.**

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

#### **2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.**

##### **(a) Maintenance of Copyright Notices.**

You must not remove or alter any copyright notices on any and all copies of the SOFTWARE PRODUCT.

##### **(b) Distribution.**

You may not distribute registered copies of the SOFTWARE PRODUCT to third parties. Evaluation versions available for download from GETYOURNET IT SERVICES's websites may be freely distributed.

(d) Rental.

(f) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the SOFTWARE PRODUCT.

### **3. TERMINATION**

Without prejudice to any other rights, GETYOURNET IT SERVICES may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.

### **4. COPYRIGHT**

All title, including but not limited to copyrights, in and to the SOFTWARE PRODUCT and any copies thereof are owned by GETYOURNET IT SERVICES or its suppliers.
